

Waiver and Release Form

I, (Parent/Legal Guardian) _____ on behalf of (Student) _____, acknowledge and am fully cognizant of the inherent dangers in connection with participating in All Heart Academy’s classes, programs, personal training and instruction, including Martial Arts, Ninja Warrior, wrestling, and related activities (referred to herein as the “Activities”) and that even when performed in conjunction with training, supervision and proper technique, the Activities require physical exertion and frequent physical contact. I realize that there is a risk (and/or probability) of physical injury that may be incurred while engaging in any of the Activities, including, but not limited to, injuries that may be permanent (in nature and/or duration) and death.

In consideration of my or the Student’s use of the facility to engage in the Activities, I hereby waive any and all claims, demands, damages, rights of action, or causes of action, present or future, whether the same be known or unknown, anticipated or unanticipated, against All Heart Academy, All Heart Martial Arts LLC and any of its members, directors, officers, affiliates, trainers, instructors, employees, and students (whom are authorized by All Heart Academy or All Heart Martial Arts LLC to perform on its behalf), and/or any other authorized agent, for any and all physical injury or death that might occur in connection with the Activities and I expressly assume the risk of all dangers or injury, including permanent, which are considered reasonably inherent to the participation in the Activities.

I hereby expressly and willfully release and forever discharge All Heart Academy, All Heart Martial Arts LLC and any of its members, officers, directors, trainers, instructors, employees and students from liability for any damages arising from physical injury (including death) sustained by me or the Student on or about the premises located at [ADDRESS] or as a result of the use of All Heart Academy’s equipment or facilities, or as a result of the participation in the Activities, regardless of whether such injuries result, in whole or in part, from the negligence of the above-referenced individuals and/or entities.

I understand that the above-referenced individuals and/or entities are not intended to be an entirely inclusive list, and nonetheless expressly release and forever discharge any additional individuals and/or entities, not specifically listed herein, but employed by All Heart Martial Arts LLC.

I expressly agree to indemnify and hold harmless All Heart Academy, All Heart Martial Arts LLC and its employees against any and all claims, demands, rights of action, of any person or entity, that may arise from injuries or damages sustained by me or the Student and voluntarily waive my right to pursue any lawsuits if the Student is injured.
